Board Activities

The new irrigation system has been installed and provides water for all three buildings, front and back. The system runs in the early morning hours starting about 1 AM and runs until all zones have been watered for 20 minutes each. There are two time clocks, one in 869 Farmington and one in 30 Outlook. The system is programmed. We ask that no one adjust the programmed irrigation system time clocks. The system includes a rain sensor that shuts the system off automatically when there is enough rain. Adequate water will promote a greener lawn and healthier plants.

A new LED light has been installed to illuminate The Westbury sign in front of 869 Farmington.

Aging and diseased shrubs have been removed from the property by JH Property Services. Some new shrubs will be planted in the spring. The bed behind 20 Outlook has been reconfigured and grass has been planted in the adjoining area. A large maple tree has been planted in the southwest corner of the lawn at 30 Outlook. Tree trimming will take place in early November. The extension of the rock wall along the Farmington Avenue driveway will be built in November.

Pet Survey

Results of the recent pet survey distributed to owners indicated owners prefer that The Westbury should be a pet-free community. The rules will be changed to reflect that decision, with the exception of cats currently in residence. Board member Yvette Blanchard will be overseeing a pet registry. Winter Parking

It has been unseasonably warm, but winter will arrive. Please be aware that to facilitate snow removal from our outdoor parking area, residents must move their vehicles from their space promptly after the end of a storm. Cars that are moved to the street during a parking ban may be ticketed.
